

We require that the “R”-value testing of your ClimaShield insulation and siding samples be done according to ASTM Test Method C-236. The ASTM Test Method C-236 is a testing method which has been accepted by the United States government for testing “R”-value of insulation. The permeability testing of your ClimaShield and siding samples shall be done according to ASTM Test Method E-96. The ASTM Test Method E-96 is a permeability testing method which has been approved by the United States government. In the event that one or both of these test methods is unavailable, the samples shall be tested according to the closest equivalent test method available, which has been approved by us. Once again, you will be required to pay for all costs resulting from the removal of your ClimaShield insulation and siding samples, including the replacement of these samples, and all of the costs resulting from the testing of the samples.

If laboratory tests prove that the ClimaShield installed on your home is defective, Progressive Foam Technologies, Inc. will refund to the homeowner, the cost of sample removal and testing.

TRANSFERABLE

Progressive Foam Technologies, Inc. makes the following limited warranty. This Warranty extends to the original consumer purchaser of the ClimaShield Contoured Underlayment covered by this Warranty, and to one subsequent purchaser of the dwelling or building onto which the ClimaShield insulation is installed. This Warranty gives you specific legal rights and you may also have other rights which may vary from state to state.

WARRANTY COVERAGE

We warrant that ClimaShield insulation's actual thermal resistance and permeability will not vary by more than five percent (5%) from its published system "R"-value and published perm rating, which are printed on the label of the ClimaShield insulation. "R"-value refers to resistance to heat flow. The higher the "R"-value, the greater the insulation power. Perm rating refers to resistance to the movement of water vapor. The lower the perm rating, the higher the resistance to vapor transmission. Any product with a perm rating of 1 or less is a vapor barrier. The date of manufacture for each package of ClimaShield insulation is clearly printed on the package.

We further warrant that the structural integrity of the ClimaShield insulation will remain intact for the lifetime of your home. The ClimaShield insulation will not crumble or disintegrate behind your siding.

In order for this warranty to apply, we require that the ClimaShield insulation be installed according to our specifications, recommendations and application instructions in effect at the time your ClimaShield insulation is installed.

EXCLUSIONS

In the event you cause any alterations, damage or repairs to be made to your ClimaShield insulation, we will not cover these under this Warranty unless you make them in a manner prescribed and accepted in advance by us, in writing.

We have not authorized any of our representatives to make any representations or promises to you, except for those contained

in this Warranty, and there are no warranties or guarantees which extend beyond the terms of this Warranty. ALL STATE LAW IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO THE SAME LIFETIME DURATION OF THE LIMITED WARRANTY SET FORTH ABOVE. Note: Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

WE WILL NOT BE LIABLE TO YOU UNDER ANY CIRCUMSTANCES FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, SUCH AS INCREMENTAL HEATING, COOLING OR SIMILAR COSTS AND HARM TO PROPERTY, RESULTING FROM YOUR CLIMASHIELD INSULATION'S FAILURE TO COMPLY WITH THIS WARRANTY. Note: Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

PERIOD OF COVERAGE

This Warranty covers your ClimaShield insulation for as long as the original consumer purchaser or the subsequent owner live in or own the dwelling or building onto which the ClimaShield insulation is installed.

PROBLEM RESOLUTION

In the event your ClimaShield insulation is tested according to the terms of this Warranty, and its thermal resistance or permeability have fallen by more than five percent (5%) of its published system "R"-value and perm rating, we will:

1. Deliver to you a quantity of equivalent ClimaShield product. Progressive Foam Technologies, Inc. will pay for material and labor to replace your non-performing ClimaShield insulation: OR
2. If we are unable to provide replacement insulation, or if you agree with us to accept a refund, we will refund to you the original price of the non-performing ClimaShield insulation.

PROPERTY OWNER CLAIM PROCEDURE

In the event you suspect your ClimaShield insulation's actual thermal resistance and permeability to vary by more than five percent (5%) from its published system "R"-value and perm rating, you must provide us with written notice of this suspected variance within thirty (30) days. You must mail this notice to the address listed below:

After we have received your notice of suspected variance, you will be required to provide us with samples of your ClimaShield insulation and siding so that the "R"-value of the samples may be determined. When these samples of ClimaShield and siding are removed from your home, we require that one of our authorized representatives be present to observe the removal of the samples. Furthermore, you will be responsible for paying for the removal of your ClimaShield insulation and siding samples and the testing of these samples.
